Full Wine Member. Is an actively engaged LCWA member who owns a winery and/or tasting room in Lake County, CA, or who produces bottled wine with a label that states the wine is produced from grapes grown in Lake County, CA, and who is dedicated to the purposes of the Lake County Winery Association shall be eligible for full membership. Full wine members must be properly licensed and permitted through the state and the county

Winemaker Member. A Lake County wine membership applicant who produces Lake County wine(s), but DOES NOT have a Lake County winery or tasting room although may have a Lake County vineyard operation. Any Lake County wine producer is eligible to join LCWA if interested in and committed to the purpose of LCWA.

OR

Winegrape Grower Member. A Lake County wine grape grower growing grapes in Lake County on either owned or leased land. This membership category proudly supports the efforts and activities of LCWA, but is not a voting member and does not have rights or obligations of a full wine member.
